Any applicant for exhibiting space must be 18 years old to apply for exhibiting space. Only one applicant per exhibiting space. For the purpose of this agreement any reference to the displayer/stallholder or any like references in any other documents that apply to the IEA or Mossel Bay Municipality or A.T.K.V will be in either the singular or plural if applicable.

This agreement concerns the taking of notice and abiding by the rules and regulations as laid down and stipulated.

- B. The <u>original application</u> for a stall and membership, together with this agreement form a unit. All 10x pages form this unit. As such both have to be completed in full and duly signed by the displayer before the allocated stall space comes into force. No stallholder obtains any vested interest except a temporary conditional right for a specific holiday period at and applicable to any available exhibiting space allocated or supply of electricity at any available supply point and accept absolutely that their allocation of stall space at any applicable exhibiting area is the absolute prerogative of the I.E.A. management. No claim can be made to any specific or any exhibiting space whatsoever. Each holiday period is a new holiday period for which application has to be made for again.
  - 1. Whenever the word "displayer" is used it also includes any personnel employed by the stallholder.
  - 1.1 Failure to effect full payment on or before the 8 MARCH2022 and without any contrary agreement with the I.E.A in place, the application will be cancelled without further notice. The stall space will then be allocated to another applicant. When a displayer cannot or does not want to make use of his stand, the stand will revert back to the I.E.A and given to someone else. Sub-letting will not be tolerated under any circumstances.
  - Only products approved as per the original application or by special permission from the I.E.A Committee may be offered for sale, may be sold from your stall or may be delivered from your stall. No other items/products not approved may be sold from your stall to other stallholders or to the public or delivered to anybody. No orders for products not approved may be taken from your stall by anybody. The I.E.A reserves the right to remove any product, which in its discretion, permission for sale purposes has not been obtained.
  - 1.3 The I.E.A does not in any way guarantee the quality of any stall space allocated. The onus is entirely on the displayer to make sure before the start of the season exactly where his stand is situated. The I.E.A does not in any way accept responsibility if the approved products do not sell on the stall space allocated.
  - 1.4 <u>The displayer and his personnel</u> (the displayer is at all times <u>responsible for</u> the actions and behaviour of his employees) undertake not to park any vehicle/s in front of his/her stall or in front of anybody else's stall.
  - Business hours will be from 09h00 to 17h00 or 18:00 according to arrangements in place. You have to be at your exhibiting space allocated not later than 09:00 daily and be ready to trade by 10:00. All food stalls at any exhibiting area including A.T.K.V must obtain written permission to trade later than 19:30 any day. If this is not adhered to, the stall space will, after investigation, be cancelled. The decision of the appointed Day Committee will be final. Nobody may trade later 22:00 on any day at any stall area. Each stall area must be totally evacuated by 23:00 on any day No stock, vehicles etc. Electricity users who wish to trade after 19:30 may have to pay an additional amount as determined by the I.E.A management from time to time. Contravening this rule can result in stall space being revoked immediately after an investigation. The decision of the Day management in this regard will be final. If anybody for some or other reason has to stop trading then his stall space must be totally vacated and clean within 1hour from ceasing trade to departure. Everything must be removed from the applicable stall space in such circumstances. Nobody is allowed to wait on his stall space with a heap of goods already packed for a long time without trading while the market is still in full swing.
